Take time to check on your loved ones this holiday season



For many Americans, the Holiday season is one of the few times during the year that family members visit older adult parents, friends, and relatives and spend quality time together. The Area Agency on Aging Region 9 (AAA9) urges you to pay close attention this holiday season to make certain the older adults you care about are able to care for themselves properly.

"Living away from family and friends can make looking out for their welfare difficult. Phone calls and widely spaced visits may not reveal the health needs of aging loved ones. On the phone, most older adults won't let anyone know or admit that they are in need of help," explained James A. Endly, AAA9 CEO/Executive Director. "The holiday season may be the only time families get a chance to visit and there may be drastic changes in a loved one's health. We want family members to pay close attention this Holiday Season; know what to look for and what to do if they have concerns," Endly added.

Here are some things to look for or to ask your loved one:

Is your loved one keeping their home as they usually do?

- 1. Has their physical appearance changed and not in a good way?
- 2. Is there food in the cupboards and the refrigerator?
- 3. Has their medication been refilled?
- 4. Have they removed themself from outside social activities they once enjoyed, church, etc.?
- 5. Are there unpaid bills lying around?
- 6. Do they have working smoke detectors?
- 7. Are there other signed that your loved one is neglecting themself?

"Most older adults place a high value on their independence and privacy and simply won't ask for help." The holiday season may be the time for children and loved ones to take a more active role in their parent or relative's life," Endly added.

Senior Scams ARE Elder Abuse

- Unexpected calls or emails that claim to be from the government or a utility demanding payment
- Emails or calls that say you've won a prize or gift but must pay a fee to receive it
- Requests with unusual means to submit payment, such as prepaid gift cards or wiring money
- Requests for bank account or credit card numbers.
- Pressure to act immediately or resistance when you ask for additional information.



This is the season of goodwill to all men; however, not everyone is willing to do the right thing. Unfortunately, this time of year, and the upcoming winter months, is a prime season for those who target older adults. Many older people see only the good in everyone, and many times will not report any activity that other people may see as suspicious. Given the fact that many older adults live alone, perpetrators of frauds and scams take special care to target these individuals.

During the winter months, inclement weather often results in cancelled blood drives, and seasonal illnesses like the flu may cause some donors to become temporarily unable to donate.
